CONTRACTING OPPORTUNITY FOR CBOS

LA County has established an Equity in County Contracting Initiative to invest in opportunities for small, local and emerging businesses, CBOs, and non-profit entities to foster inclusiveness, diversity and economic development. DEO has built in a pathway to County contracts for smaller CBOs through the AJCC Modernization RFP:

- \$200,000 in funding available for each selected small CBO.
- CBOs must co-apply to the RFP with a primary proposer as a secondary subrecipient.
- Indicate interest in the RFP by completing the CBO interest form on the AJCC Modernization RFP webpage, linked below. Proposers will have access to a full list of CBOs who complete the form.
- Not all CBOs who submit an interest form will be selected however there may be other funding opportunities that we will notify CBOs of in future, so please stay connected!

MINIMUM REQUIREMENTS of CBOs

- and mobility for all.
- Located and doing work in Los Angeles County
- Proof of non-profit 501(c)3 Status (RFP 3.10.1.2)
- of experience within the past 5 years. (RFP 3.10.1.1)
- Financial statements for the past 3 years and submit in Section G, along with Primary Proposer's proposal. (RFP 3.10.1.3)
- Corporate documents as detailed in Sub-section 7.6.11.2 of the RFP (RFP 3.10.1.4)
- Compliance with past County Contracts (RFP 3.10.1.5)
