एलए क्षेत्र कार्यकर्ता राहत कोष जनवरी 2025 की आंधी और जंगलकी आग से प्रभावितपात्र श्रमिकों को \$2,000 की नकद सहायताप्रदान करता है। यहधनराशि व्यक्तियों को आंधी औरजंगल की आग केकारण हुए वित्तीय संकटसे उबरने में मददकरती है।

आवेदन 6 फरवरी 2025 से 24 फरवरी 2025 तकखुले हैं। आवेदन पूराकरने में 20-30 मिनट लगते हैं, और यदि आवश्यक होतो आप इसे सहेजकर बाद में वापसआ सकते हैं।

- Applications will be accepted starting February 6, 2025 and will be open until February 24, 2025.

- Please note, you may be asked to provide supporting documentation. If you need to pause your application to gather documents, you will be able to save your progress and return later to complete your application.

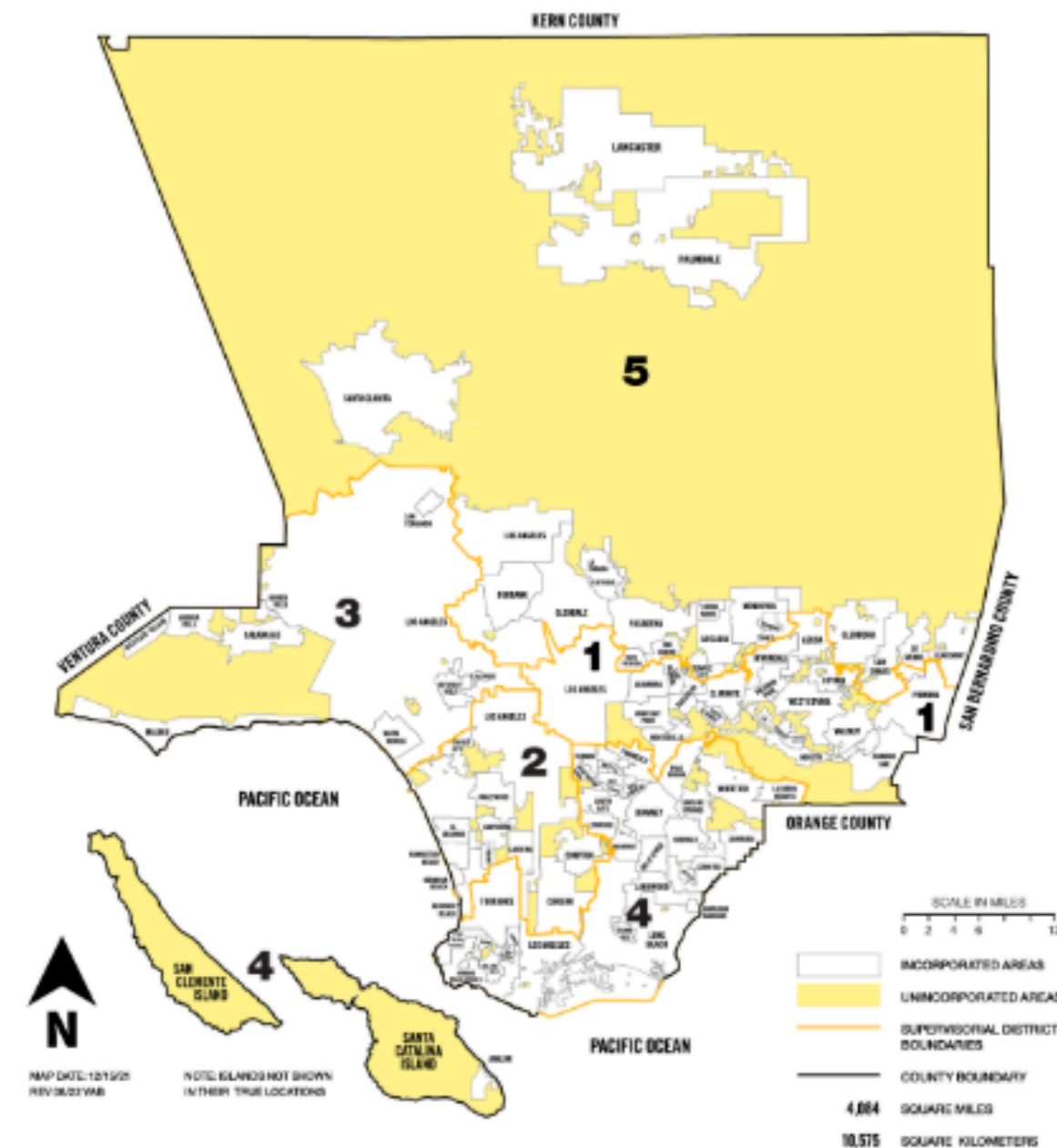
